





Mr. Mahama is also the owner of Man Bosch Ghana Limited, (MBG) a company they previously represented MAN DIESEL Trucks in Ghana and now representing RENAULT Trucks in Ghana.

He has further established a Cement processing plant - Dzata Cement. The cement factory has a capacity of 2.6 Million Tonnes per annum, and this is the highest single cement facility in Ghana. It started operations in August 2021

The over 200-million-dollar plant is expected to produce an average of 120 bags per minute from its two production lines and is enroute to create some five thousand direct and indirect jobs.


JOYCE TAMAKLOE CANCER FOUNDATION




